“Market Rules and Regulations / Prohibitions and Restrictions”

I, _____, acknowledge the fact that I have been issued and received an orientation packet which covers the following Market Rules and Regulations.

1. Not taking into, carrying through or discharging into the Facility and garbage, rubbish or waste.
2. No removal, destruction, or damage to property
3. No solicitation or begging of Alms or subscription for any purpose / Illegal Vending
4. Annoying or harassing behavior to any person
5. No interference with, encumbrance or obstruction of any part of the Facility or the operation therein.
6. Any action or conduct constituting a breach of peace
7. Refusal or attempt to avoid any charge, toll, price, fee fixed by the Association.
8. Ingaging in , insisting, or encouraging any fight or disturbance.
9. Any act injurious to any person or property.
10. Peddling or hawking.
11. Gambling or drinking alcoholic beverages in public / No Smoking
12. Having possession of an illegal firearms, knives, hatches, machetes, slingshots, fireworks or other dangerous instruments or explosives, except for firearms carry by proper permit.
13. No Scavenging – (picking up discarded produce)
14. No Jack Riding on platforms, sidewalks, or streets
15. Early Buying prohibited – Buyers must comply with hours of operation set forth by Association
16. Illegal parking, One-way Traffic pattern and Obstruction of the traffic flow
17. No Illegal use or possession of a Market ID not issued to person it was intended for
18. No unauthorized pallet removal.

HUNTS POINT TERMINAL PRODUCE MARKET ADOPTED CUSTOMER AND EMPLOYEE “FOOD SAFETY RULES”

- Good hygiene is paramount while conducting business within the market
- All customers and vendors are advised animals are not allowed in closed proximity to the fresh produce supply
- Customers and vendors must wash their hands immediately after using restrooms
- No eating, or drinking in proximity to the fresh produce supply
- No smoking near fresh food supply
- All retained vendors will refrain from repairing jacks and other mechanical devices near the fresh fruit supply
- All customers and vendors are prohibited from using illegal drugs and consuming alcohol within the confines of the market
- No glass bottles in the warehouses
- No photography
- No employee or vendor shall work while sick
- No employee shall work with produce if lacerations or abrasions are present on any part of the body.
